The organization develops and implements social and pre-employment programs to help participants integrate more independently into community life. The program is divided into three categories that leads to 20-30 events per month where participants learn to interact at more effective and age appropriate levels under the direction and supervision of organization staff. Programming includes an educational component under Social College, self-directed planning and programming under Social Focus and generalization of skills in the community under Social Growth.
