

Directions to Pathways to Independence:

From West County:

Take I-64 East to I-170 North. Take the Forest Park Parkway exit and take the second exit (up and over Forest Park Parkway). Go the stop light at Bonhomme and turn right. Follow Bonhomme to Hanley Road and turn left. (You'll be looking at our building as you come down the hill on Bonhomme). Once you turn left, you will turn almost immediately right onto Colorado. Parking is behind the building. You will enter the building on the 2nd level. Simply go to the stairs or elevator and go down 1 floor to the lobby and we are immediately to the left of the main entrance as you face the front doors to the building from the inside.

From North County:

Take I-170 south to the Forest Park Parkway exit. Take the second exit (up and over Forest Park Parkway). Go the stop light at Bonhomme and turn right. Follow Bonhomme to Hanley Road and turn left. (You'll be looking at our building as you come down the hill on Bonhomme). Once you turn left, you will turn almost immediately right onto Colorado. Parking is behind the building. You will enter the building on the 2nd level. Simply go to the stairs or elevator and go down 1 floor to the lobby and we are immediately to the left of the main entrance as you face the front doors to the building from the inside.

From South County:

I-270 north to I-64 East to I-170 North. Take the Forest Park Parkway exit and take the second exit (up and over Forest Park Parkway). Go the stop light at Bonhomme and turn right. Follow Bonhomme to Hanley Road and turn left. (You'll be looking at our building as you come down the hill on Bonhomme). Once you turn left, you will turn almost immediately right onto Colorado. Parking is behind the building. You will enter the building on the 2nd level. Simply go to the stairs or elevator and go down 1 floor to the lobby and we are immediately to the left of the main entrance as you face the front doors to the building from the inside.

From St. Louis City:

Bring I-64 west to Grand. Turn right (north) on to Grand. Go approximately 3 blocks and turn left onto Forest Park Parkway. Follow Forest Park Parkway into Clayton and exit at Shaw Park Dr. At stop light, turn right onto Bemiston. At first stop light, turn right onto Bonhomme and turn left. Follow Bonhomme to Hanley Road and turn left. (You'll be looking at our building as you come down the hill on Bonhomme). Once you turn left, you will turn almost immediately right onto Colorado. Parking is behind the building. You will enter the building on the 2nd level. Simply go to the stairs or elevator and go down 1 floor to the lobby and we are immediately to the left of the main entrance as you face the front doors to the building from the inside.

From St. Charles County:

Bring I-70 east to I-170 and follow the directions from North County or bring the Page Extension east to I-270. Take I-270 South to I-64 East and follow the directions from West County.
